## Reaching for 100,000. . .

. . . A message from **MJCRSP President Charles Jehlen**



It is almost impossible for the average person to imagine the range of emotions going through the minds of educators today. Even those of us with public school experience have limited comprehension of the difficulties in transitioning to distance learning on a national scale. How will they teach electives? VoTech? Extracurriculars? How to best meet the socio-emotional needs of a diverse student population while maintaining physical separation? Each district is plowing new ground and we should continue to pray for all the employees and students.

Our local unit will have a small taste of this changed process as we use Zoom to conduct our meetings for the rest of this calendar year. Tim Lee has challenged us to reach 100,000 members in 2020. We will need everyone on board as the Texas Legislature begins its session in January. The pandemic will add additional costs and reduced income to state and local governments. TRTA is dedicated to maintaining the TRS funding levels established in 2019.

I want to publicly thank Lynne James for her dedicated and persistent efforts in strengthening our unit. Lynne, the committee chairs, and the members have perfected a system that facilitates communications between the state and the individual retired educator. All programs are running on schedule. Being the new kid on the block has its advantages. I enjoyed hiring a teacher from another district or state who would observe my school's functions and ask "Why are you doing this?" If I couldn't justify the program or process to a fellow educator, change was needed. After spending my first year of membership asking questions, I can assure you our unit needs no changes. MJCRSP is in excellent shape and has the assets and institutional knowledge to continue serving our members and communities.

In order to meet Mr. Lee's challenge of 100,000 members, we will need to increase our outreach efforts - especially to the newly retired educators. Since we will not have our September welcome luncheon, I urge each of you to contact the eligible non-members you know and urge them to join TRTA and MJCRSP right now. The two selling points that spoke to me were TRTA's legislative influence and AMBA. When I was president of the Texas Association of Secondary School Principals, it was my privilege and honor to speak to legislators in both Austin and Washington. This is the time to prepare, so that after the November elections TRTA will promote its members with a louder voice. Are you ready?

**HEALTH INSURANCE CHANGES COMING:** We have known for some time that our health insurance will change January 1. As usual, when a change in health insurance takes place, TRS annuitants have the opportunity to attend seminars to hear of major changes, if any, and changes in premiums and deductions. This year the seminars will be webinars, so you can learn from the comfort of our homes. (Gotta love this virus!) Webinars begin in October and you must register to attend. **SCHOLARSHIP ADS:** Our scholarship program has been very successful since we began in 2017. Eight high school seniors have received a combined total of \$9,400, made possible through the support of local merchants who have purchased ads in our yearbook and contributions from members. In view of the economic effect of COVID, some of the merchants may not be able to renew their ads when our ad campaign resumes in October. Begin thinking now of merchants in our community who do not currently have an ad. Perhaps you can approach them later to help sponsoring our scholarships! Yearbooks with scholarship ads will be available at the October meeting.

**VOLUNTEERS:** Providing services to the community is our purpose, but our volunteer program has been stifled by the pandemic. So we must reimagine and adapt how our hours can be accomplished. Many of us have turned to making masks for those who need them, mending clothes and stuffed animals for children. Others have been tutoring, helping neighbors with chores, grocery shopping for others or using FaceTime to visit the ill or sequestered. Be aware that our Community Volunteer Hours are counted from January through December 2020. Our goals for 2020 are to maintain our increasing member participation and continue educating members on what counts as a volunteer hour.

**HELEN'S HEALTH TIP:** As September gets closer, it is time to think about needed vaccinations, such as the flu shot (vitaly important in this COVID-19 year) and other important shots. More on this topic at the September meeting.
