

Mid-Jefferson County Retired School Personnel Minutes  
Tuesday, February 9, 2016

The regular meeting of the Mid-Jefferson County Retired School Personnel was held at Ritter Senior Citizen Center, Nederland, Texas, on February 9, 2016, at 1:30 p.m.

The meeting was called to order by President Gail Krohn. She also led the invocation. Pledges of allegiance were led by Clara Graham. Refreshments were provided by Chairman Candice Zummo, Gail Krohn, Donna Lumpkin, and Diane Trevey. The minutes of the January 12<sup>th</sup> meeting were emailed to a few members with some distributed for reading at each table.
