

Mid-Jefferson County Retired School Personnel Minutes
Tuesday, January 12, 2016

The regular meeting of the Mid-Jefferson County Retired School Personnel was held at Ritter Senior Citizen Center, Nederland, Texas, on January 12, 2016, at 1:30 p.m.

The meeting was called to order by President Gail Krohn, and the invocation was led by Mary Beth McDuff. Pledges of allegiance were led by Candice Zummo. Refreshments were prepared by Chairman Rose Reese, Linda Briggs, Becky Dungan, and Linda Fong. The minutes of the December 8th meeting were emailed to a few members with some distributed for reading at each table. There being no additions or corrections, the minutes were approved by committee and floor as read. Treasurer Mary Beth McDuff reported that, as of December 31st, the balance on hand was \$6,987.91. The report was filed for audit.
