

Mid-Jefferson County Retired School Personnel Minutes  
Tuesday, March 8, 2016

The regular meeting of the Mid-Jefferson County Retired School Personnel was held at Ritter Senior Citizen Center, Nederland, Texas, on March 8, 2016, at 1:32 p.m. The meeting was called to order by President Gail Krohn and the invocation was led by Donna Lumpkin. Pledges of allegiance were led by Rosalie Reese.

**Committee Reports:**

**Membership** – First Vice President Clara Graham reminded the members that we still need to recruit new members as well as past members. The membership year started March 1<sup>st</sup> and membership forms are available on our website. Extra forms are available at each meeting.

**Legislative** – Richard Briggs reported that TRTA has been focusing on the primary elections. Our Senator and Representative had no opposition, but the main issue for retired teachers will continue to be health care. We still do not know how we will be impacted.

**Community Volunteer Services** – Chairman Jessie Howard thanked all members who sent in their volunteer hours and encouraged us to continue recording our volunteer hours starting from January 1, 2016. It was also mentioned that volunteers were welcomed to work in the United Methodist Church (Nederland) booth at the Nederland Heritage Festival.

**Health Care** – Chairman Helen Reynolds shared that the Zika virus (related to yellow fever and West Nile virus among others) was first isolated in 1952, and will continue to be in the news because it is pandemic in Brazil, the site of the 2016 Summer Olympics. More information will be forthcoming about this health concern in the coming months.

**Protective Services/Memorial & Get Well** – Chairman Linda Fong shared that Alice McEntire has been diagnosed with Crohn's Disease and no longer drives. Also, that 03/17/16 is her 89<sup>th</sup> birthday! Linda also told us of many scams and false claims by many companies and projects: "You've Won!"; FTC alerts that Luminosity's claims regarding brain improvement games; and Life Lock was fined \$1 million for violating settlements and failed to establish and protect people's personal information. CBS also did a piece on the Wounded Warrior Project scam.

**Technology** – Chairman Lynne James reminded the membership that items for the newsletter are due March 24<sup>th</sup> and that assembly will be on March 31<sup>st</sup>. She also asked Loretta Morman and Olive Hall to take pictures at the April 12<sup>th</sup> meeting as she will be at convention.
