

Mid-Jefferson County Retired School Personnel Minutes  
Tuesday, November 13, 2018

The business meeting of the Mid-Jefferson County Retired School Personnel was held at Ritter Senior Center in Nederland, Texas, on Tuesday, November 13, 2018, at 1:30 p.m. The meeting was called to order by President Lynne James. The invocation was given by Helen Reynolds, and pledges of allegiance were recited by everyone.
